Chapter Community Outreach Grants. The Foundation provides funding to support community service or outreach/pro bono projects that involve FBA chapter participation. Projects must address the need for legal services in the community or fall under any component of the Foundation's mission. Grant applications are accepted twice during the Foundation's fiscal year (June 15th and December 15th). Currently the maximum grant amount is \$5,000 and the number of grants awarded each year will be dependent upon available funding and the number and quality of applications. All chapters are encouraged to apply.

Ilene and Michael Shaw Public Service Awards. Made possible by the generous contributions of Ilene and Michael Shaw, the Federal Bar Association each year seeks to recognize the many public service programs sponsored by FBA chapters nationwide. Designed to assist and encourage members in providing service to their communities, the Ilene and Michael Shaw Public Service Award is designed to assist and encourage FBA chapters in providing service to their communities. The Ilene and Michael Shaw Young Lawyer Public Service grant enables FBA chapters to provide service to the public through the development and implementation of public service projects and pro-bono law-related services. In order to encourage an increased and continued commitment to public service responsibility by young lawyers, these projects must be administered under the auspices of a chapter Younger Lawyers Committee.

Kitner Public Service Scholarship. The Public Service Scholarship provides \$5,000 as assistance to a graduating high school senior planning to attend a four year college or university. At least one of the parents (or guardians) of the student must be a current federal government attorney or federal judge and member of the Federal Bar Association.

FBA Chapters working on Hurricane Katrina Rehabilitation. The Foundation of the Federal Bar Association recently granted funds to two FBA chapters the New Orleans Chapter and the Mississippi Chapter to support chapter philanthropy projects related to serving communities most severely affected by Hurricane Katrina. These FBA chapters are working in partnership with Rebuilding Together New Orleans and Habitat for Humanity to help repair, renovate and rebuild storm-damaged homes.

Moot Court Competition. The Foundation provides financial support to the Thurgood Marshall Memorial Moot Court Competition, sponsored by the Federal Bar Association's Younger Lawyers Division.

Elaine R. "Boots" Fisher Award. This award is intended to stimulate, encourage, and recognize exemplary community, public and charitable service by members of the FBA. The Foundation makes an annual charitable contribution of \$1,000 to an organization for which an FBA member has performed outstanding public service.

The Fellows program was established in 2001 to provide recognition to individuals who have demonstrated exceptional commitment to and leadership within both the Federal Bar Association and the legal community. Each Fellow makes a personal commitment to financially support the work of the Foundation. These charitable contributions support the Foundation's many programs and initiatives, including Chapter Community Outreach Grants, scholarships, research, education and awards.
