Taxpayer received a charitable donation in 2001 of 1100 shares of Diversa common stock which had a market value of \$12,000 at the time of the gift. Taxpayer continued to use this original value as the book value of this asset until the shares were sold in the current tax year.

In 2014 these shares (which had been converted to shares in Verenum Corp) were called in by the Corporation and Taxpayer received \$338 for these shares.

These events resulted in a loss on Taxpayer's books of \$11,662, and a taxable gain of \$338 because the Taxpayer's basis was 0, even though the book value of the shares was \$12,000, the value when the shares were received as a donation.
