NW PROVIDES BOTH TEMPORARILY AND PERMANENTLY RESTRICTED FUNDING. TEMPORARILY RESTRICTED FUNDING RELATED TO THE REHABILITATION LENDING PROGRAM IS FOR MAKING LOANS SPECIFICALLY FOR THE REHABILITATION OF AFFORDABLE HOUSING UNITS IN THE CNHS TARGET AREA. THE FUNDS ARE REQUIRED TO BE SEGREGATED FROM THE NW PERMANENTLY RESTRICTED REVOLVING CAPITAL FUND. THE PERMANENTLY RESTRICTED FUNDS ARE FOR MAKING LOANS AND FOR FUNDING CAPITAL PROJECTS. THE ORGANIZATION IS PERMITTED TO TRANSFER OR EXPEND THE INCOME (OR OTHER ECONOMIC BENEFITS) DERIVED FROM THE CAPITAL ASSETS IN EXCESS OF THE RELEVANT CAPITAL FUND AGREEMENT. THE SBA LOAN PROGRAM WAS SUSPENDED IN A PRIOR YEAR. THE PROGRAM PROVIDED FINANCING FOR WORKING CAPITAL AND START-UP COSTS TO SMALL BUSINESSES IN TARGETED COMMUNITIES. THE PROGRAM WAS FUNDED WITH PROCEEDS RECEIVED FROM TWO LOANS WITH THE U.S. SMALL BUSINESS ADMINISTRATION. BOTH LOANS WERE PAID OFF AS OF SEPTEMBER 30, 2011. CNHS CONTINUES TO SERVICE ALL SBA LOANS THAT HAVE BEEN PREVIOUSLY FUNDED AND ONLY MAKES NEW LOANS UNDER SPECIAL CIRCUMSTANCES. THE MAGGIE CAZARES LOAN FUND WAS ESTABLISHED WITH THE DONATION OF A LOT BY A PRIVATE DONOR, AND THE PROCEEDS FROM THE SALE WERE PERMANENTLY RESTRICTED. THE PROCEEDS WERE THEN USED TO PROVIDE DOWN PAYMENT ASSISTANCE OR ASSISTANCE TO CLEAR UP DEROGATORY CREDIT FOR AN INDIVIDUAL QUALIFYING FOR HOME PURCHASE WITH A MAXIMUM AMOUNT OF \$1,500 PER CLIENT.
