I.

The name of this corporation is THE OBRIA FOUNDATION, INC.

II.

This corporation is a nonprofit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

The specific purpose of this corporation is to receive contributions and make donations to, to dispense charitable contributions through, and otherwise aid and support those organizations qualified for exemption from Federal Income Tax under the Internal Revenue Code of 1954, as amended, that are organized and operated exclusively for religious or charitable purposes, including counseling and financial support to any woman facing crisis pregnancy as well as other types of assistance.

This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

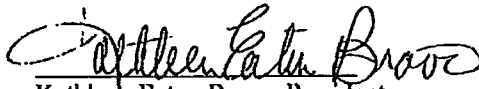
