The U.S. Space & Rocket Center Foundation supports the educational programs and projects of the U.S. Space & Rocket Center and Space Camp, through grants, fundraising, scholarships, events, and corporate programs.

Through the fundraising efforts of the Foundation, donations are made and allocated to the U.S. Space & Rocket Center for scholarships to attend Space Camp and other educational museum programs. Space Camp and affiliated programs provide hands on learning of Science, Technology, Engineering, and Math (STEM) in an immersive setting using Space Exploration as the theme and backdrop. This same technique is applied to our educator programs and not only teaches our educators but provides learning tools and inspiration that they can take back to the classroom. In FY14 258 teachers received scholarships to attend Space Academy for Educators, and 599 students or special needs children were scholarship recipients. Based on restrictions from donors, travel, expenses are often covered by the scholarship funds in addition to lodging and meals throughout the program. The Foundation granted funds to the U.S. Space & Rocket Center to fund additional museum exhibitions. During the fiscal year the museum hosted five traveling exhibits. The first was an exhibit titled "Raise the Roof" (Science Museum of Minnesota). The exhibit featured full sized and miniature structures and buildings to teach the architect and engineering of buildings. Following that we hosted GPS Adventures which taught skills in navigation, from compasses and maps to GPS and satellites. At the same time we hosted a photographic exhibition titled "Two Lines" which depicted the similarities and differences of the Korean DMZ and the Berlin Wall. In August we exhibited a Smithsonian Institution exhibit titled "Black Wings" which told the history of African American pilots and astronauts and the discriminating challenges they had to overcome. In August we also opened a new permanent exhibit called "NASA's Great Observatories" displaying graphics and models of the 5 great observatories from Compton Gamma Ray to the yet to be deployed "James Webb Space Telescope". All of the exhibits have strong educational components and come with Educational materials for the teachers.

The Foundation solicited funds from corporate and private donors to sponsor several major events throughout the year. The following events were supported by these funds: July 4th Fireworks, Be-Ready Camp, Inventors' Ball, the NASA Rover Challenge Races, the Pass the Torch series of speakers which is open and free to the public, and the annual Space Exploration Celebration. All of the aforementioned events were hosted by the U.S. Space & Rocket Center but underwritten by funds raised by the Foundation. These events support the missions of the Foundation and keep the community at large engaged and up to date on what is current in the museum.
