Reef Foundation Project Summaries 2013-2014

New York Harbor School Foundation Project: The Billion Oyster Project BOP IS AN ECOSYSTEM RESTORATION AND EDUCATION PROJECT aimed at restoring one billion live oysters to New York Harbor and engaging hundreds of thousands of school children through restoration based STEM education programs. Students at New York Harbor School are growing and restoring oysters in New York Harbor and using **reef balls** as part of the oyster restoration. BOP is a partnership of schools, businesses, nonprofits, and individuals all working together to grow oysters and make our city a healthier and more resilient place to live. The project was founded by New York Harbor School and built over the past four years through extensive collaboration and consultation with teachers, scientists, engineers, architects, policy makers, and local communities who are actively working to restore their local marine environment.

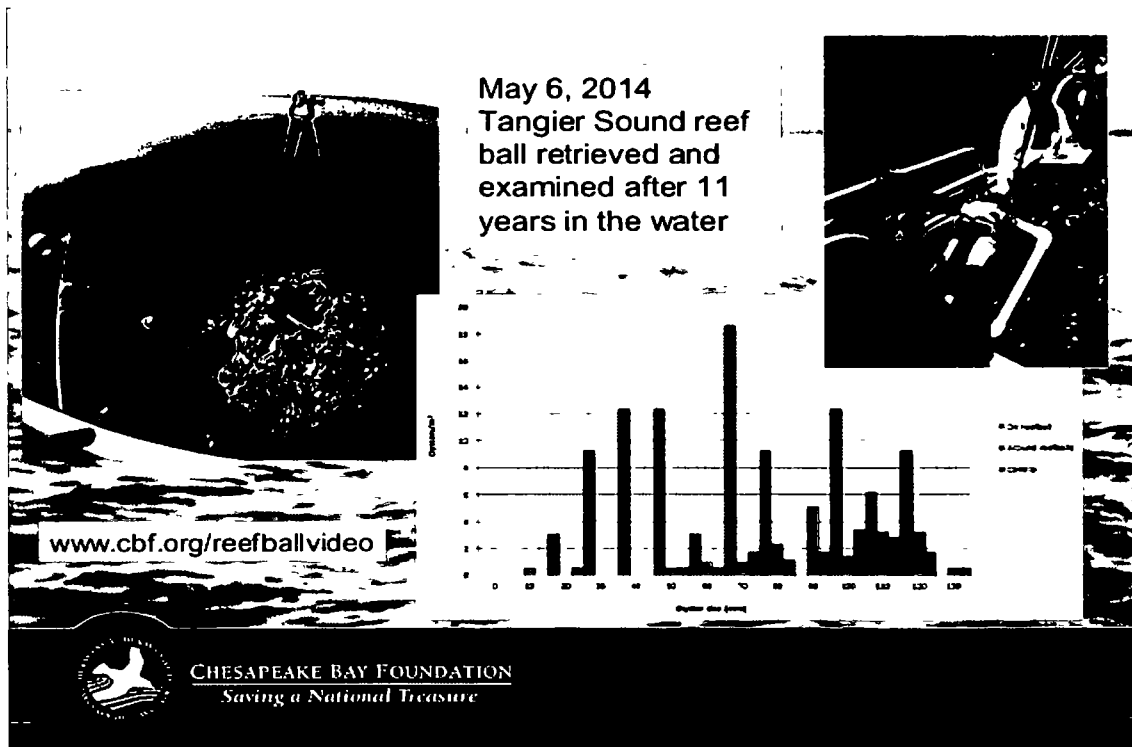
NYNJ Baykeepers:

Baykeeper's restoration work focuses on repopulating the New York and New Jersey bays with oysters and creating sustainable habitat in order to monitor and improve the health of the estuary's eco-system.

Our Oyster Restoration Program is pivotal for the health of the Estuary. Oysters are a keystone species that provide structure and habitat needed for many other species to survive. NYNJ has done a 3 phase pilot study for restoration using reef balls and other methods. NY/NJ Baykeeper has installed reef balls in its 1/4 acre reef in Raritan Bay.

Chesapeake Bay Foundation:

The Chesapeake Bay Foundation's reef ball program has continued to expand with some very positive monitoring results: On May 6, 2014, the Chesapeake Bay Foundation organized an expedition to investigate the Somerset Oyster Sanctuary restoration site in Tangier Sound, one of three sites designated by the Maryland General Assembly. What researchers discovered about the value of reef balls for oyster restoration was remarkable. See photo with mature reef ball.



Conclusions

- 3-D oyster reefs, once common in Chesapeake Bay, were a key part of the estuarine system, very much like the coral reefs of the tropics
- The Bay's 3-D reefs were destroyed historically
- Bay users have grown accustomed to a flat Bay, but vertical relief should be part of oyster restoration
- Reef balls are a viable option for 3-D reefs:
 - ✓ Oysters appear to grow better than on the surrounding bottom
 - ✓ Spat-set reef balls provide suitable reef habitat for fish

CHESAPEAKE BAY FOUNDATION
Saving a National Treasure

Town of Chesapeake Beach: Town of Chesapeake Beach partnered with the Maryland Department of Natural Resources' Marylanders Grow Oysters program to provide a fun and collaborative opportunity for the citizens and businesses of Chesapeake Beach to help improve local water quality and their knowledge of the Bay ecosystem, while

assisting with national, state and private efforts to restore the Chesapeake Bay through oyster cultivation and oyster reef restoration. They constructed 42 Oyster Reef Balls for deployment on Old Rock Reef. Presented project to multiple state and federal agencies to receive permit

FixFiber Reef Ball Italy: Reef Ball Italy continues to do pilot and research projects with reef balls for erosion control, breakwaters and habitat restoration in Venice and nearby areas.

State of Tennessee: The Tennessee Wildlife Resources Agency is using reef balls for a research project for fresh water reservoir habitat enhancement in several locals throughout the state.

Miami Port Mitigation Project: Reef Balls are being used as a mitigation project for a wharf and sea wall refurbishment at Port Miami-Miami-Dade Department of Environmental Resources Management's restoration and enhancement section.

BREEF Bahamas Project: The Sir Nicholas Nuttall Coral Reef Sculpture Garden is a one of kind snorkeling and SCUBA diving experience for Bahamians and visitors that serves as a multipurpose hub for the marine environment including: A perfect fusion of art, education and marine conservation that provides habitat for fish, corals and other marine organisms. Diverts snorkelers and divers away from natural reefs and provides an exceptional out classroom for environmental education and citizen science. The reef balls form the backbone of the snorkel trails and restoration.

Grant Stadler Boyscout Project Troop 793: Small reef ball project with the Boy Scouts in Maryland

Living Shorelines Oyster Mitigation Craney Island Virginia: Shoreline erosion control and restoration practices using only plantings and organic materials to restore, protect or enhance the natural shoreline environment. This project also involved mitigation for the impacts from constructing a new port on 522 acres of existing open water habitat.

Philippines Project: An ambitious coral reef rehabilitation project to heal thousands of acres of reefs that were destroyed by dynamite fishing in the Philippines. We are partnering with the owner and staff of Kaliksi, a private island to be the home base for Reef Ball construction. The Reef Ball Foundation will also send our Coral Team to train a resident marine biologist to perform Reef Ball Foundation certified in situ coral propagation (asexual reproduction) and planting on the Reef Balls that will be deployed. The program is ambitious with a container load of molds and coral planting supplies that was shipped over and construction was done in May 2014. The program is anticipated to be ongoing using local labor for construction and local supplies.

Verizon Commercial on related project: Reef Balls were featured in a Verizon commercial based on a research project in New York. Verizon has brought humans closer together through a technologically advanced network spanning internet, cable and phones. Now, with innovation and creativity, Verizon has managed to bring sea life a new life. Providing underwater sensors and artificial reefs, making their water, and ours, cleaner.

Zanzibar Tanzania Project: Project in Partnership with the Mwambao Coastal Community Network in Jambiani, Zanzibar working with the local community leaders and fisherman, schools and community groups to bring sustainable fisheries by habitat restoration through reef ball. Also will be doing coral transplant work. Community planning began in 2014 and molds were shipped, but project travel plans were delayed until January 2015 because of shipping and customs hold ups and issues associated with Ebola outbreak.

Clean Nova Scotia: Training and deployment continues for our project in Nova Scotia with Clean Nova Scotia on habitat restoration.

Austin Eco Conference: Todd Barber and Kathy Kirbo attended the Eco-conference as associated with a panel based on a series on Al Jazeera called Earthrise where the work of the Reef Ball foundation was featured. The panel was called "Power of Positive: Successful Stories of Grassroots Change

DEMA: Reef Ball Foundation has a booth at the Diving and Tourism trade show in Orlando that is attending by worldwide government entities, dive related businesses and non-profits. Many of the reef ball family attended this event.

Reef Ball staff and volunteers attend many conferences, school and community events through out the year.
