The home delivered meal program delivered 205,778 nutritionally balanced meals to a daily average of over 712 homebound and disabled clients living in Collin County. All eligible clients are assessed by case managers who are licensed social workers and identified as nutritionally at risk based on the results of a scientific holistic needs assessment tool. Meals are delivered Monday - Friday between 11:00 - 1:00pm by volunteer and staff drivers who provide a safety check to help ensure the client's well-being and safety by alerting emergency contacts or services when a client is injured or fails to answer the door. Breakfast and frozen meals for the weekend were delivered to some recipients based on their nutritional risk. Shelf stable meals were delivered for holidays and emergencies when severe weather does not permit regular delivery. The case managers provide ongoing case management, follow-up and emergency support services.

The congregate meal program served over 7,600 meals to seniors 60 years and older in four senior center sites. Nutritious lunches are provided Monday - Friday between 11:00 - 12:00 noon for seniors who are able to attend the local senior centers. Transportation is provided to seniors in McKinney to the congregate meal site. Seniors call before 12:00 noon daily to make reservations for a meal.

The senior safety net program provides additional services to client that includes medical alert buttons, medical assistance, utility assistance, pet food, and emergency assistance.
