These events include a golfing event, , a Vegas night, and others. These events help to raise funds that help provide the mentioned services. Directors of Sarah's House are volunteers. They live in the community and work in their respective professions. The directors are NOT compensated for their time spent working at Sarah's House (Schedule 990 Part VI, Section B, Questions 15a and 15b) as shown in Part VII, Section A of Form 990. Duties of the Director are divided and range from administration, to fundraising, to facility maintenance. This year, fundraising efforts have been down, but grants have helped us to continue to provide the necessary support to help us continue our mission, and this year, we have even been able to expand our efforts by cutting down some of our costs and expenses. Our Board of Directors insures that all monies are used for program expenses, exempt related activities, and keeping a small, loyal staff, compensated for their efforts. We also had NO unrelated business gross income, as all our income comes from grants, contributions, and interest income coming from our accounts. We have 3 members of our governing body; Dana Martin, our board Chair, Laverne Roese, our Treasurer and Executive Director, and Rick Guerro, Member, that insure all our efforts are executed to the best of their abilities. PART VI Question 11 This return was reviewed, in detail, with the board Treasurer overseeing the financial compilation and reporting. Once all questions and concerns were clarified, the return was filed with the IRS. Question 12 In 2010, then board Chair and the board secretary drafted written policies with respect to conflict of interest, among others. These policies were finalized and approved. The Directors and Key Employees are required by the Chair to disclose annually that they are not involved in activities giving rise to conflict of interest in performing their duties at Sarah's House. The board also, annually, fills out a questionnaire to make sure all possible conflicts and other concerns are correctly handled.
