Compassion Programs Global Action has many compassion programs with the main focus being on orphans. We provide numerous camps during the summer and Christmas months allowing orphans to be in a loving environment where they are cared for, encouraged, and taught lessons from the bible. Global Action is also working on "Hope Centers" (currently in two locations) that provide temporary housing and schooling through grade 8 for children under extreme duress, allowing them to grow in a loving family environment.

Ministry Coordination Global Action maintains nine international offices worldwide; these offices are headquarters for projects in each of their respective countries. Global Action provides ministry and project support for each office as part of its program services; this support allows the offices to hire locally thereby supporting the local community (various project areas) as part of its outreach.

Training Programs Global Action's training program is called GLOMOS. It stands for Global Module Studies. The program teaches pastors who have not had any formal Bible school training. It is a 9-month course that teaches biblical basics and is nondenominational. The goal is multiplication in that these pastors then train others in their towns and villages. Courses are taught in Ukraine, Nepal, India, Honduras, Guatemala, and El Salvador.
