Food & Clothing to the Needy of the Community/Adopt a Block-The organization distributes food & clothing at no cost to those within the community who need help & assistance. The organization is feeding approximately 7,600 meals per week during community outreaches through food bags & hot meals. The organization is also providing approximately 4,500 pieces of clothing weekly to those in need.

4b (Code:) (Expenses \$ 820,740 including grants of \$ 129,440) (Revenue \$ 99,257)
Feeding, housing, clothing & training disciples-The organization provides short & long-term, no/low cost housing for individuals 18 years of age or older as well as training (life-skills, financial, relational & spiritual) & clothing to those who need help, assistance & rehabilitation. City Help, Inc of Phoenix houses approximately 300 individuals per week. Approximately 6,400 meals are given out to residents & participants on a weekly basis.

4c (Code:) (Expenses \$ 360,504 including grants of \$ 47,719) (Revenue \$)
Hope Wing-The Hope Wing provides a stable, safe environment for young girls & women (typically between the ages of 14 & 26) who have been caught up in the human trafficking pipeline and wish to get out or find themselves in a crisis pregnancy. Long term housing is not an option for minors who have no legal guardianship established. This program is a therapeutic transitional living program geared toward the spiritual, emotional and physical healing of these young women. This free program provides housing, food, clothing, medical care, legal assistance, counseling and training to assist in the transition to a normal, productive life participated in this program.
