Wildlife restoration AESs 250 volunteers work with the U S Forest Service and Az Game and Fish Department on collaborative projects to maintain and enhance wildlife habitat Programs include Boy Scout Eagle Scout Projects AES volunteers, employees and contractors hauled over 200,000 gallons of water for wildlife, restored and maintained over 50 wildlife water catchments and 16 dirt water tanks When completed the water projects will add over 5 million gallons of capacity for new water Projects and volunteers worked on riparian restoration, creek channel rebuilding, fence removal and enclosure maintenance, cleared over 200 acres of jack pines for grassland restoration, removed nine miles of unneeded barbed wire fence, maintained riparian cattle enclosure fencing and fixed two springs for wildlife AES had 250 volunteers working wildlife restoration projects and provided 203,000 in grant funds to Az Game and Fish Department for wildlife from hunt tag auction sales
