In FY 2014 Disability Rights Washington (DRW) protection and advocacy for individuals with developmental and intellectual disabilities (PADD) helped obtain appropriate community based services for over 10,000 individuals, provided technical assistance services to 1,606 individuals and training to another 728 individuals on 26 different occasions. 10 publications were developed to help people with a range of disability rights related issues and, over 4,000 times, these and other existing DRW publications were accessed by visitors to DRW's website which had a total 38,882 unique visitors. One example of our work includes a case in which we were involved that resulted in children with autism covered by Washington Regence plans getting previously denied neurodevelopmental therapies to treat mental health conditions for the insured over seven years old. This positive result impacted thousands of children. In another example, residents of a nursing home benefitted from a DRW investigation that found multiple violations in the care for 27 individuals. In response to DRW's findings, the Center for Medicare and Medicaid Services (CMS) came in and did follow-up investigations. They found 40,000 legal violations and took immediate action.

4b (Code:) (Expenses \$ 573,275 including grants of \$ 573,275) (Revenue \$ 1,046,427)

In FY 2014 DRW's protection and advocacy for individuals with mental illness (PAIMI) helped address rights violations and secure services for over 49,000 individuals, provided individual advocacy services to 586 people and training to another 4,088 individuals at 57 different activities. One example of our work with this program involved patients who had been court ordered for civil commitment, but were being boarded in local emergency rooms due to lack of space at appropriate settings. As a result, the liberty interests of hundreds of individuals were being restricted without requisite treatment. DRW submitted an amicus brief along with the ACLU and NAMI to inform the court of the harm that comes to individuals who are involuntarily committed and remain in emergency rooms while waiting for an evaluation and treatment bed. DRW also worked extensively with the firms representing the 10 individuals who had been warehoused in emergency rooms without adequate care and treatment pursuant to the single bed certification rule. On August 7, 2014, the Washington State Supreme Court issued a unanimous decision ruling in favor of DRW's position and issued an order to correct the problem.

Amplifying Voices of Inmates with Disabilities (AVID) PRISON PROJECT (LFW) - A privately funded project for issues of individuals with disabilities in and leaving prisons includes Technical Assistance Services. In the last six months of the year, DRW provided Technicl Assistance via telephone or letter approximately 421 times to 386 individual prisoners. Monitoring and Outreach: AVID staff visited 8 prisons, monitoring the conditions of confinement of 2,934 individuals. AVID posters have been placed in every facility, which has led to an increased demand for AVID Technical Assistance Services. Systemic Advocacy: In July, AVID and DOC announced an agreement about our collaboration to end DOC's practice of punishing inmates who harmed themselves or attempted suicide. This was a major accomplishment that many states have only achieved after prolonged litigation. AVID continues to meet regularly with DOC to discuss strategies to address systemic issues related to medical care, accommodations in communication for inmates with disabilities, and treatment for certain populations in segregation.
