Proposals are accepted through the advertised Request for Proposal (RFP) process or by a request for a proposal to a specific entity to meet the work plan needs. These proposals are peer reviewed by our Science & Technical Committee. If approved, they then go to the Board Chair (appointed by U S Secretary of Commerce) who approves. The grants are then awarded, or amended if from prior years. Deliverables, financials and reporting expectations are included in the award documentation.
