Part III. Statement of Program Service Accomplishments

4. Describe the exempt purpose achievements for each of the organization's three largest program services by expenses.

4a) (Expenses: **\$624,518** including grants of \$75,867 and Revenue: \$624,518)

In August 2012, TDG received a \$2.5 million, 4-year award from the **National Science Foundation DRK-12 program** to study the efficacy of the *Mathematics Studio* professional development model. TDG's Executive Director, Linda Foreman serves as Principal Investigator of this project, *Enhancing Mathematics Teaching and Learning in Urban Elementary Schools* (EMTL). Portland State University's (PSU) Department of Mathematics and Statistics is a sub-awardee, and all of the professional development is situated in Tacoma Public Schools in Tacoma, WA. EMTL project funding supports three years of professional development for all grades 3-5 teachers and principals in Tacoma Public Schools, and the funds support 4 years of research centered on that professional development. All professional development is provided by TDG staff members, and all research for the project is conducted by mathematics educators and researchers from TDG and PSU. All expenses named above are associated with the professional development and research for this project.

4b) (Expenses: **\$375,446** and Revenue: \$524,037)

During fiscal year 2014, the **Mathematics Learning Laboratory Project in Hamilton County Department of Education (HCDE)** involved 250.5 days of professional development services for the district's highest needs urban schools. These services included: Mathematics Learning Laboratories in 14 schools (each Learning Laboratory involves 4 or 5 cycles of from 2-4 days of professional development); Science Learning Laboratories in two schools; 18 days of support for Mathematics Coaches; 3 four-day seminars, *Best Practices in Teaching Mathematics: How Math Teaching Matters*; 2 four-day seminars *Best Practices in Teaching Science: How Science Teaching Matters*; and 2 four-day seminars, *Best Practices in Teaching Mathematics: Mathematically Productive Engagement*. The total expenses shown above include the costs of instruction and planning, and instructor travel. Additional costs *not* shown in this total include: costs associated with instructor travel/coaching for 20 days of training; development and maintenance of each school's Online Math Collaborative, online Teaching Surveys and online reporting services for HCDE leaders; development, printing, and shipping of program materials; support for the development of a grant proposal; and day-to-day operations expenses associated with setting up and managing the professional development services.

4c) (Expenses: **\$200,891** and Revenue, \$349,292)

During fiscal year 2014, the Math Studio project in Salem-Keizer Public Schools included the following 166 days of mathematics professional development services: 5 Mathematics Studios (each Math Studio involves 4 or 5 cycles of from 2-4 days of professional development); 8 four-day seminars, *Best Practices in Teaching Mathematics: How Math Teaching Matters*; 2 four-day *Best Practices in Teaching Mathematics: Mathematically Productive Engagement* seminars; 14 four-day cycles of Summer School Mathematics Studios; and 15 days of Grade Level Collaborative Team Planning. This work was all situated in the district's highest needs, lowest performing schools. Additional costs *not* shown in this total include: costs associated with instructor travel/coaching for 20 days of training; development and maintenance of each school's Online Math Collaborative, online Teaching Surveys and online reporting services for SKPS leaders; development, printing, and shipping of program materials; on-site and virtual support for implementation and day-to-day operations expenses associated with setting up and managing these professional development services.
