DURING THE TAX YEAR, THE ASANTE FOUNDATION'S LARGEST PROGRAM SERVICE ACCOMPLISHMENT WAS THE GRANTING OF \$664,623 TO BENEFIT VARIOUS DEPARTMENTS AND CAPITAL PROJECTS AT ROGUE REGIONAL MEDICAL CENTER (RRMC), A 378 LICENSED BED HOSPITAL LOCATED IN MEDFORD, OREGON OF THE CAPITAL PROJECTS,OVER \$268,000 WAS DONATED TO REMODEL THE FRANCES CHENEY FAMILY PLACE. MUCH LIKE RONALD MCDONALD HOUSE, THE FRANCES CHENEY FAMILY PLACE IS A HOME AWAY FROM HOME FOR FAMILY OF PATIENTS AT RRMC. THIS GENEROUS DONATION ALLOWED THE ROOMS, KITCHEN AREA, AND GARDENS TO GO THROUGH A MUCH NEEDED RENOVATION. A DONATION OF \$127,697 WAS RECEIVED TO PURCHASE NICU TRANSPORT EQUIPMENT FOR THE TRANSPORTATION OF CRITICALLY ILL NEWBORNS THAT NEED TO BE MOVED FROM ASANTE ROGUE REGIONAL MEDICAL CENTER TO DOERNBECHER CHILDREN'S HOSPITAL IN PORTLAND. OVER \$44,000 WAS DONATED THIS YEAR TO COMPLETE THE NEONATAL INTENSIVE CARE UNIT (NICU) REMODEL AND EXPANSION. THIS CAPITAL PROJECT ALMOST DOUBLES THE OVERALL SIZE OF THE NICU AND ADDS AN ADDITIONAL 10 BASSINETS AND GIRAFFE BEDS. ALL NEW HIGH EFFICIENCY LIGHTING AND PATIENT MONITORING SYSTEMS ARE INCLUDED IN THE PROJECT. NOW COMPLETED, THE OVERALL INCREASE IN PATIENT VOLUME IS EXPECTED TO BE MODEST, BUT THE MAJOR FOCUS OF THE NEW EXPANSION IS TO INCREASE THE EFFICIENCY AND QUALITY OF CARE TO THE BABIES AND THEIR FAMILIES IN ADDITION TO DONATIONS FOR CAPITAL PROJECTS, THE ASANTE FOUNDATION ALSO HELPS SUPPORT NUMEROUS CLINICAL DEPARTMENTS AT RRMC. THIS INCLUDES GENEROUS DONATIONS OF OVER \$34,000 TO THE CRITICAL CARE UNIT FOR A PILOT PROGRAM AND OVER \$51,000 TO HELP OPERATE THE FRANCIS CHENEY FAMILY PLACE. THE HOSPICE DEPARTMENT RECEIVED \$19,805 OF DONATIONS. THE FOUNDATION ALSO PROVIDED NEARLY \$34,000 FOR FREE MAMMOGRAMS AND BREAST CANCER EDUCATION FOR UNINSURED WOMEN IN THE VALLEY. OTHER DONATIONS HELP SUPPORT THE WOMEN'S IMAGING CENTER, THE EMERGENCY DEPARTMENT, THE MENTAL HEALTH DEPARTMENT, AND THE DUBS CANCER CENTER.

THE ASANTE FOUNDATION'S SECOND LARGEST PROGRAM SERVICE ACCOMPLISHMENT IS THE GRANTING OF \$148,135 TO HELP SUPPORT VARIOUS DEPARTMENTS AND CAPITAL PROJECTS AT THREE RIVERS MEDICAL CENTER (TRMC), A 125 LICENSED BED HOSPITAL LOCATED IN GRANTS PASS, OREGON. DURING THE TAX YEAR, THE FOUNDATION CONTRIBUTED \$8,500 TO INSTALL A DEMO KITCHEN FOR DIABETIC PATIENTS TO COME AND LEARN HOW TO LEARN ABOUT AND PREPARE MEALS FOR THEIR NEW DIAGNOSIS. THE FOUNDATION ALSO MADE CONTRIBUTIONS OF OVER \$16,900 TOWARD THE CONSTRUCTION OF THE NEW THREE RIVERS OUTPATIENT CLINIC. IN ADDITION TO CAPITAL PROJECTS, THE FOUNDATION CONTRIBUTED OVER \$122,628 IN GENERAL OPERATING DONATIONS. THIS INCLUDES \$26,698 TO THE THREE RIVERS FAMILY HOUSE, AND \$17,600 TO THE SPEARS CANCER CENTER. OVER \$12,700 WAS DONATED TO HELP SUBSIDIZEDFREE MAMMOGRAMS TO UNINSURED WOMEN THROUGH A GENEROUS GRANT FROM THE CONNIE FISKE FOUNDATION. OTHER DEPARTMENTS THAT BENEFITED FROM FOUNDATION DONATIONS INCLUDE THE EMERGENCY DEPARTMENT AND THE IMAGING DEPARTMENT.

THE ASANTE FOUNDATION'S THIRD LARGEST PROGRAM SERVICE ACCOMPLISHMENT WAS APPLYING FOR AND RECEIVING SIGNIFICANT GRANTS FROM VARIOUS PHILANTHROPIC FOUNDATIONS AROUND THE COUNTRY. THE FOUNDATION, PARTNERING WITH THE REGENCE FOUNDATION, COMMITTED AN ADDITIONAL \$9,988 TO COVER THE COSTS OF CONFERENCES AND EDUCATION FOR NURSES AND OTHER MEDICAL PERSONNEL TO LEARN MORE ABOUT PALLIATIVE CARE AND PAIN MANAGEMENT. ALSO, THE ASANTE FOUNDATION HAS MADE DONATIONS TO THE KOHL'S FIT KIDS PROGRAM IN THE AMOUNT OF \$20,307. IN ALL, THE ASANTE FOUNDATION GRANTED \$30,295 TO THE VARIOUS OTHER PROGRAMS THAT HELP SUPPORT ASANTE. THE ASANTE FOUNDATION'S ON-GOING MISSION IS TO CONTINUALLY ASSESS THE NEEDS OF THE HOSPITALS IT SUPPORTS, AS WELL AS THE COMMUNITY WE SERVE. OVER THE YEARS, THE FOUNDATION HAS CONTRIBUTED MILLIONS OF DOLLARS TO HELP SUBSIDIZED IMPORTANT CLINICAL DEPARTMENTS OF THE HOSPITALS AND HELP PURCHASE NEEDED MEDICAL EQUIPMENT. IT HAS ALSO MADE SIGNIFICANT CONTRIBUTIONS TO MAJOR BUILDING PROJECTS AT ROGUE REGIONAL MEDICAL CENTER AND THREE RIVERS MEDICAL CENTER.
