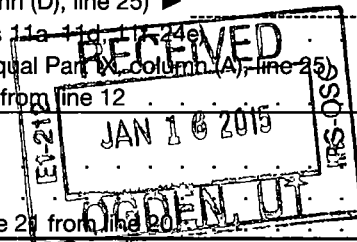

Local APCA Chapters host various events to help raise funds for the high school scholarship program (information listed below) and community programs. Events include 1) dinners where we provide networking opportunities for our employees, educational guest speakers and silent auctions, 2) Cultural Events during Lunar New Year, Asian Heritage Month and Diwali to encourage Cultural enrichment of Asians and non-Asian employees, 3) Dragon Boat Races to expose employees to the cultural activity while practicing teamwork, 4) Lunch and Learn meetings and webinars on self-development topics, 5) Health & Wellness Fairs to educate members and employees on health-related matters, 6) recognition events to encourage members to be engaged in APCA activities and supporting a wide variety of community projects, and 7) food and toy drives to benefit low income families in the communities in which we work. See Schedule G for a breakdown of income and expenses from events.

4b (Code:) (Expenses \$ 94,225 including grants of \$ 94,000) (Revenue \$ 0)

APCA distributed \$93,000 in scholarships to 58 graduating high school seniors who were accepted to two or four year accredited universities. Students who applied online had to submit their transcript showing they had a GPA in excess of 3.4 on a 5 point scale, send letters of recommendations, write an essay on a topic we provided, and demonstrated they were a leader by showing their leadership skills through their involvement in school or community programs. APCA received over 700 applications from throughout the states where APCA serviced. Over 100 APCA volunteers called schools to obtain the appropriate contacts at local high schools to distribute the scholarship applications, and helped judge the applications. All applications were tabulated based on their GPA, essay, community involvement and letters of recommendations; the top 15 applicants each received a \$2,000 national scholarship (\$30,000). The other applicants were then sent to the local Chapters, who selected from the pool of candidates from their state to receive \$1,000 or \$2,000 scholarships (43 students, \$63,000). One chapter gave out two \$500 scholarships to individuals who participate in the local CAAMFest. The same Chapter also paid for partial scholarships for two members to attend the Corporate Asian American Employee Network Leadership Development Program (\$225). See attached support material. When Typhoon Haiyan hit the Philippines, APCA called upon its members and AT&T employees to help those that were impacted by the Typhoon by making monetary donations to help victims rebuild their lives. Through local face to face and online collections, we collected \$19,963. The funds were given to the Oakland, CA, American Red Cross office in January, 2014, with instructions that the funds be used for the benefit of the Haiyan victims.
