The Foundation supported the local youth of the community by supporting public school counseling and guidance departments and by supporting the youth Kiwanis Clubs (Builders and Key Clubs). The Foundation supported Children's Hospital, the YMCA camps for youth and the burn camp, the San Diego Youth Food Bank, and other youth service organizations.
