The booth provided information about farm products in their raw state and what those products were made into. We had grains for people to see and touch and food products that are made from those grains. There was also information on farm safety. 18 volunteers were able to interact with the public and educate them about agriculture and where their food comes from. Over three days, approximately 4,500 members of the general public attended Ag Days.

 St Joseph County Farm Bureau, Inc educates school-age children about agriculture by using the Ag in the Classroom program. Approximately 600 students, from kindergarten through fifth grade, were able to participate in this program.
