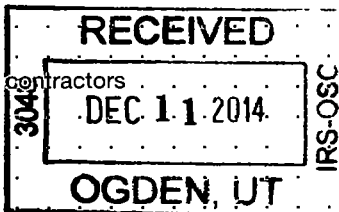

The organization's purpose is to enhance the lives of disabled and disadvantaged young people through charitable activities including developmental therapeutic, educational and recreational programs through horses and horse related activities.

PART III. Statement of Program Service Accomplishments (Line 28): Equine Assisted Therapy

We have fifteen children in the program with three on a waiting list. Of the fifteen in the program two are on full scholarship. All others are on partial scholarship as program fees cover approximating 40% of actual costs. Accomplishments in its second year include but not limited to establishing a bimonthly newsletter, receipt of a grant from Autism Speaks Neighborhood Grant program to establish a new program, added a new therapy horse to the herd while realizing a 100% increase in participation.
