THE GRANTS PROGRAM IS A STATEWIDE RESOURCE FOR SUPPORT OF A WIDE VARIETY OF LECTURES, FESTIVALS, PANEL DISCUSSIONS, WALKING TOURS, AND THE PLANNING AND IMPLEMENTATION OF EXHIBITIONS AND OTHER VENTURES AT SMALL AND LARGE NOT-FOR-PROFIT INSTITUTIONS THROUGHOUT NEW YORK STATE.
