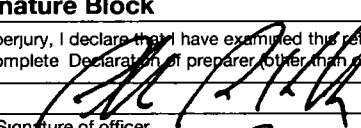

1) The scholarship will be used to attend an organized music school or lessons from an eminent teacher(s)/musician(s), possibly involving significant travel expenses; 2) Eligible applicants must be active club members, in good standing, who have helped organize club activities, participated in gigs, lead workshops or slow jams, held offices, or done other deeds recognized as being for the benefit of the club and corporation's mission; 3) Each scholarship awardee must commit to giving back to the organization by conducting a workshop on what they learned, writing an article about their experience for the newsletter, or otherwise enriching the club by sharing what they have learned; 4) The scholarship may not be used to attend either of the Scottish Fiddlers of CA sponsored music camps; 5) Preference will be given to those who have not previously been awarded a Fiddle Club Scholarship, and the scholarship will cover only the person applying. The scholarship awardee will be expected to pay a portion of the training on his or her own as our award will not cover the whole expense; 7) The scholarship will be awarded contingent on evidence of acceptance into a school or program or by a teacher. If circumstances change and the scholarship awardee is not able to participate in the training, the funds must be refunded to SFSF. The Scholarship Committee reviews each applicant based on the above criteria and makes a decision on scholarship award and amount.
