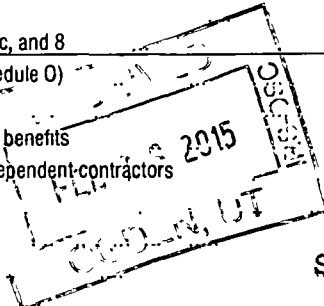

WHEREAS, we recognize that we are at a financial crossroad and that long term financial sustainability is critical; however, the resources already entrusted to us require that we assess the cost-benefit; be it

RESOLVED, that pursuant to a duly made and seconded motion, the following resolution was adopted by the affirmative and unanimous vote of the Board of Directors of Smart Start Centre County, Inc. (hereinafter referred to as Corporation) to dissolve the organization effective June 30, 2013.

RESOLVED FURTHER, that Dissolution shall:

1. Be in accordance with the provisions of the Bylaws, Article X, as follows:

"Should there be a dissolution of the Corporation, the Board of Directors shall, after paying and making provision for the payment of all liabilities of the Corporation, distribute all of its remaining assets to such institutions which are described in Section 501 (c) (3) of the Internal Revenue Code of 1986 which are closely related in purpose of function to the Corporation, as the Board of Directors of the Corporation in its sole discretion may determine."

The Board directs that all remaining assets shall be transferred to the Centre County United Way.

2. Current obligations to complete projects underway will be honored and completed.
