FINALLY, THE GOVERNING COMMITTEE'S DECISION MAY BE APPEALED TO THE ILLINOIS DIRECTOR OF INSURANCE WITHIN 35 DAYS AFTER THE DATE OF THE GOVERNING COMMITTEE'S DECISION.
