4. GRANTS WILL BE AWARDED AT SUCH TIMES, IN SUCH AMOUNTS AND UPON SUCH TERMS AND CONDITIONS AS THE SELECTION COMMITTEE BY UNANIMOUS VOTE SHALL FROM TIME TO TIME DETERMINE.
5. THE SELECTION COMMITTEE SHALL BE COMPOSED OF THE 3 DIRECTORS OF THE FOUNDATION WHO SHALL CONSULT WITH EDUCATORS PRIOR TO MAKING ANY DETERMINATION.
