EASEMENTS AND ACQUISITIONS Winterwood Farm FCT is working with the owners of a 46-acre horse farm on Webster Road to protect the farm as a farm forever In the fall of 2014, FCT, with the landowners, advanced the legal process to establish a conservation easement on the farm by completing an appraisal and signing a Purchase and Sale agreement, contingent on securing sufficient funding FCT applied for Land for Maine's Future funding in February and secured a commitment of \$105,000 in July In addition, FCT officially requested that the U S Department of Agriculture Farm and Ranch Lands Protection Program (FRPP) increase its \$90,000 commitment to \$132,500, which FRPP is in the process of reviewing FCT has a plan to secure the remaining funds through donations and grants FCT's goal is to complete purchase of this agricultural conservation easement by the end of 2015 Harraseeket and Cousins Rivers FCT is discussed land protection possibilities with a family who owns a prominent property on the Harraseeket River and with a family who owns a large parcel of undeveloped land adjacent to one of FCTs preserves on the Cousins River FCT filed Letters of Intent with the Maine Natural Resources Conservation Program for grant funding towards purchase of part of these properties, and FCT was invited to submit full proposals for both projects FCT has had initial conversations with owners of two other nearby Cousins River properties about conservation possibilities Baseline Reports Baseline/current conditions reports for 17 FCT properties were completed this year While it is now our practice to prepare such a report at the time a property is protected, that was not the case historically Through this project, FCT now has reports for all of the properties on which we hold conservation easements These are required to secure accreditation from the Land Trust Alliance As part of our annual easement property inspections in the fall we will share the reports with landowners and seek concurrence that the report accurately reflects current conditions on their property FCT Policies an updated conflict of interest policy was adopted following a Land Trust Alliance model Fundraising and Membership A fall membership appeal and spring newsletter were mailed town-wide Business Partners were recruited and renewed Land for Maine Future funding for Winterwood Farm was secured
