During 2014, CR, Inc. established the Flying Start Fund (the "Fund") to receive donations made through the fundraising activities of British Airways staff and the public. The funds raised are to be used in furtherance of the Fund's objectives jointly agreed between CR, Inc. and British Airways. CR, Inc. retains ultimate discretion and control over the use and expenditure of the monies contributed to the Fund.

In the summer of 2014, Comic Relief UK, a charity registered in the UK under charity registration number 326568, agreed to Heads of Terms with NBC Universal for the production of a Red Nose Day telethon to be broadcast on May 21, 2015. The telethon will be modelled on the successful operation of Red Nose Day over the past 25 years in the UK. CR, Inc. has entered into a license agreement with Comic Relief UK for the use of the trademarks and the provision of knowhow whereby CR, Inc. will manage the campaign and the relationship with NBC Universal and other corporate and non-profit partners. The proceeds of the event will be received by CR, Inc. into the Red Nose Day Fund, and CR, Inc. will be responsible for the disbursement of the funds including grants to preselected charitable organizations.

The program services costs of \$621,548 include grants of \$585,000. \$135,000 of this grant amount was allocated from the Flying Start Fund. The remaining \$450,000 was allocated from unrestricted funds to the Tahoe Institute. The Tahoe Institute grant is to be paid in 3 equal installments, of which the first was paid in 2014, the second is due in 2015 and the final payment will be made in 2016.
