This program improved schools community based businesses by establishing an ongoing agriculture project that currently includes greenhouses, broilers, and layers. A community water system is being built to supply water, at a minimal cost, to about 1000 homes in the community. Health care is also a major need and plans are being developed to provide sustainable health care Pastoral training is now being provided. The orphanage started in 2013 is now a certified Hatian adoption orphanage and was funded at \$105,892 for the last year. Establish woodshop for training local Haitians - \$7159 Building projects - \$39882 Missions teams airfare, lodging etc - \$99,257 Agncultural projects including chicken houses, greenhouses, and water sourcing - \$10500 School lunch feeding program - \$15545 Fuel and vehicle maintenance for all projects - \$18750 Expenses legal fees for land - \$5350 Land Purchase - \$5000 Miscellaneous - \$4000 Water Project grant - \$29203 Church construction - \$7025 Laptop for all projects - \$6166 Other misc projects - \$19,312

The job training and personal counseling is designed to improve their lives. The project has a facility where the women work as a team with design help to make jewelry and Christmas ornaments for sale, largely in the USA. Design consultants from the USA are now living in the town and are working daily to assist this work.

4c (Code:) (Expenses \$ 5714 including grants of \$) (Revenue \$ 20603) Together We Can - Ethiopia. Stephen Carlton, originally from Oregon, met and then married Ubah from Bahir Dar, Ethiopia. They are serving the elderly who are living in poverty and intend to extend this service into children's work as well. Plans are underway to partner with social agencies in the country as well as local churches.
