St Mary’s Bank’s Charitable Giving Theme is Children, Families and Individuals in Need St Mary’s Bank proactively supports the communities it serves through a number of programs and initiatives with the commitment of monetary and non-monetary resources St Mary’s supports many non-profit and social service agencies through donations and sponsorships In 2014, St Mary’s Bank supported approximately 130 organizations through donations and sponsorships for a total of about \$144,000 St Mary’s also has a formal Community Outreach Program that is delivered through partnerships with local non-profit and social services agencies Programs include a number of specific programs to assist the underserved including Family Emergency Loans (FEL), Individual Development Accounts (IDAs) and Grants for 501 (c)(3), non-profit organizations In 2014, St Mary’s awarded nine (9) grants totaling approximately \$18,300 to non-profit organizations In addition, \$6,400 in FEL’s were made to individuals and families in need In 2002 and 2003, St Mary’s established two Medallion scholarship funds - St Mary’s Bank Medallion Fund and Armand Lemire Medallion Fund respectively These funds are administered by the NH Charitable Foundation and intended to assist members enrolling in accredited vocational or technical programs In 2014, a total of three (3) scholarships for a total of \$5,500 were awarded In addition, last year our employees collectively volunteered over 1,500 hours of their time by serving on Boards of non-profits and volunteering for various community related events St Mary’s also allows non-profits partners to use meeting space at the Operations & Education Center free of charge

St Mary’s Bank participates with a number of lender organizations offering homeownership programs that assists the under-served including, FHA, VA, USDA-RD, NHHFA, FNMA-My Community, FNMA-ROC, and FNMA-HARP St Mary’s Bank also offers Portfolio Financing options and in 2014 introduced its own new program, “Welcome Home First-time Homebuyer Program “St Mary’s Welcome Home program is designed to help borrowers better understand their overall credit, determine how much house they can afford, choose the right mortgage and avoid potential pitfalls As important, the program offers real monetary benefits including - Reduced Interim Rate Cap - Mortgage Insurance Premium Reduction - Access to a Full-Range of Online Research Tools - Access to Free Homebuyer EducationIn addition to identifying lending opportunities for first-time homebuyers, we will also continue to focus on lending to income-eligible families More specifically, lending to families whose household income is at or below 115% of the area median family income (defined and published by the Department of Housing and Urban Development)


