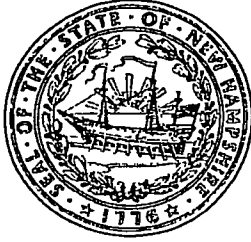





Article 1 is hereby replaced as follows:

Article 1: The name of the organization is Chocorua Lake Conservancy

Article 2 is hereby replaced as follows:

Article 2: The Chocorua Lake Conservancy is organized as a public charity exclusively for charitable, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and, to the extent consistent therewith, the objects for which the Chocorua Lake Conservancy is established are:

- To acquire, hold, and manage land and interests in land, and to engage in activities, all for the protection, preservation, and restoration of the scenic and natural resources of the Chocorua Lake watershed and surrounding area;
- To conduct and model sustainable forestry operations on its lands;
- To monitor and to engage in activities designed to protect and preserve the quantity and quality of the waters of Chocorua Lake, its sources, and its outflow;
- To engage in activities that support and maintain the unique characteristics of the Chocorua Basin National Historic District;
- To permit public access to its lands and, specifically, to maintain and manage facilities for passive public recreation where appropriate; and

- Through education, outreach, modeling, and community activities, to develop a community of support for the purposes and activities of the Chocorua Lake Conservancy.

Article 3 is hereby replaced as follows:

Article 3: The Chocorua Lake Conservancy shall be non-partisan and non-sectarian, and shall take no part in or lend support to the election or appointment of any candidate for public office. No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by R.S.A. 501-H), or participating in, or intervening in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidates for public office.

Article 4 is hereby replaced as follows:

Article 4: In complying with the purposes contained herein, the Chocorua Lake Conservancy adopts the following powers:

- a. To take title to, receive and hold, convey, lease, sell and resell, in fee simple or otherwise, property, either real, personal, or mixed, wherever situated or however acquired, without limitation as to amount of value;
- b. To encumber property by deed of trust, pledge or otherwise;
- c. To borrow money and secure payment of same by lien;
- d. To construct, maintain, and/or reconstruct any and all buildings, houses, or other structures as necessary, proper, or incident to the carrying out of the objects and purposes stated herein;
- e. To have the full powers of management, investment, reinvestment, and the collection of all rents, revenues, issues, and profits arising herein;
- f. To use the collected fees and contributions in the advancement of the

Chocorua Lake Conservancy's purposes and in the exercise of its powers and duties;

g. To form committees and sub-committees necessary to accomplish the purposes of the Chocorua Lake Conservancy:

h. Insofar as permitted by law, to do any other things that in the opinion of the Board of Directors are in the best interests of and will promote the purposes of the Chocorua Lake Conservancy.

Article 5 is hereby replaced as follows:

Article 5: Any person or his or her estate made a party to any action, suit, or proceeding because he or she, is or was a director, officer, or employee of the Chocorua Lake Conservancy shall be indemnified by the Chocorua Lake Conservancy against the reasonable expenses, including attorney's fees, actually and necessarily incurred by her/him in connection with the defense of such action, suit, or proceeding, or in connection with any appeal therein, except in relation to matters as to which it shall be adjudged in such action, suit, or proceeding that such officer, director or employee is liable for negligence or misconduct in the performance of his or her duties. The foregoing right of indemnification shall not be deemed exclusive of any other rights to which any officer or director or employee may be entitled apart from the provisions of this section.

Article 6 is hereby replaced as follows:

Article 6: Consistent with the provisions of New Hampshire RSA 292:2, the Directors shall not be liable to the Chocorua Lake Conservancy for monetary damages for breach of fiduciary duty as a director, an officer, or both, except with respect to (1) any breach of the director's or officer's duty of loyalty to the Chocorua Lake Conservancy or its shareholders; (2) acts or omissions which are not in good faith or which involve intentional misconduct or a knowing violation of law; and (3) any transaction from which the director, officer, or both, derived an improper personal benefit. It is the intent of the undersigned incorporators that directors and officers of the Chocorua Lake Conservancy shall be free

from liability for services rendered to the Chocorua Lake Conservancy to the fullest extent permitted by law. The limitations on liability herein set forth shall, accordingly, be interpreted to provide the greatest possible protection from liability under the law as it exists on the date of any occurrence or claim which would, in the absence of the protection herein set forth, result in a potential claim against a director or officer.

Article 7: The Board of Directors shall, at all times, maintain a conflicts of interest policy consistent with the provisions of New Hampshire RSA 292:1, et seq, as amended, and rules, policies, or procedures adopted or recommended by the Director of Charitable Trusts of the New Hampshire Attorney General's Office or any successor agency having jurisdiction over charitable organizations.

Article 8 is hereby replaced as follows:

Article 8: The principal office of the Chocorua Lake Conservancy shall be located in Tamworth, New Hampshire.

Article 9 is hereby replaced as follows:

Article 9: No part of the net earnings of the Chocorua Lake Conservancy shall inure to the benefit of any director or officer of the Chocorua Lake Conservancy, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Chocorua Lake Conservancy by persons other than Directors), and no director or officer of the Chocorua Lake Conservancy, or any private individual shall be entitled to share in the distribution of any of the Chocorua Lake Conservancy's assets upon dissolution.

Article 10 is hereby replaced as follows:

Article 10: In the event of dissolution, all assets and property of the Chocorua Lake Conservancy shall, after payment of all liabilities and necessary expenses therefore, be distributed to a not-for-profit corporation of similar purpose, which may or may not have been created to succeed the Chocorua Lake Conservancy, and which is organized and is operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code of 1986 as from time to time amended. In the event no such organization of similar purpose exists, then the remaining assets and property of the Chocorua Lake Conservancy shall be distributed to any fund, foundation, or organization which is organized and operated exclusively for the purposes specified in the aforementioned Section 501(c)(3).

Article 11 is hereby replaced as follows:

Article 11: This Chocorua Lake Conservancy shall be exempt from Federal Income Tax, pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

This organization is, therefore, established for the tax-exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles of Agreement, the not-for-profit corporation shall not carry on any activities not permitted to be carried on by a not-for-profit corporation exempt from

Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Article 12 is hereby replaced as follows:

Article 12: The Articles of Agreement may be amended only by a majority vote of the Directors, at a meeting duly noticed for the purpose of amending these Articles.
