The difference between the standard rates (or discounted rates if negotiated or eligible) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged against the allowance for doubtful accounts. The costing methodology used in determining the amounts reported above was a ratio of cost to charge.

Control the cost of care through innovative programs and the use of shared resources National healthcare reform demands lower costs and higher quality from all hospitals, requiring collaboration in patient care across all providers: from primary care to specialist, from ambulance to hospital, from hospital to rehabilitation to home care, from local hospital to tertiary (specialty hospital) care. Therefore, Androscoggin Valley Hospital, Upper Connecticut Valley Hospital and Weeks Medical Center have formed this joint venture to identify and implement sustainable opportunities for our future.
