Since 2001 FII has innovated new approaches to economic and social mobility to demonstrate that low-income families have the initiative and capacity to move themselves out of poverty. FII currently partners with more than 1,000 families comprising nearly 4,000 adults, youth, and children) across seven FII sites in Boston, Oakland, San Francisco, Fresno, New Orleans, Albuquerque and Detroit. FII captures data about their journeys toward economic security and well-being, and designs financial resources that families leverage to magnify their initiative. FII families start small businesses, pool financial & social capital, invest in their educations, and improve their health & well-being. On average families have achieved 2-year gains of more than 20% in earnings & 200% in savings. Our work in movement building toward large-scale policy change is at the heart of all that we do. This year, in all of our activities our family sites, partnerships, technology advances, convenings, communications, and movement-building efforts our focus continues to be on the data and stories of FII families and the impact of the FII approach. Working with like-minded individuals and organizations in the philanthropic, governmental, non-profit, and private sectors, FII continues to advance our efforts toward large-scale change in public opinion and social sector practices, with the end result of building social and economic mobility for families across the country. Through the leadership of FII families themselves and through strategic partnerships around the country, we are growing a national movement to change policies affecting low-income families in the U.S.
