MACHIK'S PRIMARY PURPOSE IS TO INCUBATE SOCIAL INNOVATION IN TIBET AND TO STRENGTHEN COMMUNITIES THROUGH PROGRAMS FOR SUSTAINABLE COMMUNITIES, THE SUMMER ENRICHMENT PROGRAM (SEP), WOMEN'S EMPOWERMENT, YOUTH LEADERSHIP, SOCIAL ENTREPRENEURSHIP AND GOVERNANCE. THE ORGANIZATION

THE CHUNGBA PROJECT ---MACHIK CORP (OR MACHIK) FOUNDED THE AWARD WINNING RUTH WALTER CHUNGBA PRIMARY SCHOOL IN THE RURAL COMMUNITY OF CHUNGBA ON THE EASTERN EDGE OF THE TIBETAN PLATEAU. THE SCHOOL PROVIDES FREE EDUCATION AND BOARDING FOR ABOUT 700 RURAL TIBETAN CHILDREN IN BOTH PRIMARY AND MIDDLE SCHOOL. THE CHILDREN'S PARENTS ARE ALMOST ALL ILLITERATE FARMERS AND NOMADS. THESE STUDENTS ARE THE FIRST LITERATE GENERATION IN THE HISTORY OF THIS REMOTE COMMUNITY. SINCE THE SCHOOL FIRST OPENED IN 2002, THESE RURAL CHILDREN HAVE BEEN THE TOP PERFORMERS IN THE COUNTY IN TIBETAN. GRADUATES OF THE PRIMARY SCHOOL PLACE HIGHLY IN BOTH TIBETAN AND CHINESE LANGUAGE TESTING, THEREBY SHOWING THE VITAL IMPORTANCE OF MOTHER-TONGUE BASED BILINGUAL EDUCATION. MACHIK ALSO CONTINUES TO SUPPORT THE NON-TEACHING STAFF SUPPORT AND THE MIDDLE SCHOOL GRADUATES TO ATTEND HIGH SCHOOL IN OTHER COUNTIES. MACHIK ALSO SUPPORTED THE FIRST GROUP OF HIGH SCHOOL GRADUATES FROM CHUNGBA TO ATTEND POST-SECONDARY EDUCATION.

ALSO, SEP CONVENEED TIBETAN, CHINESE, CANADIAN AND AMERICAN VOLUNTEER TEACHERS TO INSTRUCT THE STUDENTS AND CREATE A UNIQUE ENVIRONMENT OF INNOVATION, LEARNING AND CARE.
