THE NURSES WORK WITH LOCAL CANCER CARE PROVIDERS TO PROVIDE A SINGLE, CONSISTENT POINT OF CONTACT FOR CLINICAL QUESTIONS AND CONCERNS. NURSE NAVIGATORS EFFECTIVELY ADVOCATE ON BEHALF OF PATIENTS AND THEIR LOVED ONES WHO OFTEN FIND THEMSELVES ADRIFT IN UNCHARTED WATERS. NURSE NAVIGATORS KNOW WHERE TO LOOK AND WHO TO CALL TO GET QUESTIONS ANSWERED. THEY EXPLAIN PATIENTS' DIAGNOSIS AND TREATMENT AND MONITOR THEIR PROGRESS.
