REC Ministries was founded in April, 2002. The ministry's purpose is to spread the Good News of Jesus Christ throughout the world. In 2014, Dr. Cottle preached and taught in at least nine different states. Additionally, he produced and recorded a number of Biblical studies, ranging from The Ten Commandments to the Seven Churches of Revelation.

REC Ministries is the personal ministry of Ronald E. Cottle, Sr. During the year 2014, Dr. Cottle visited at least nine different states preaching, teaching, and conducting seminars, all centered on the Gospel of Jesus Christ. Additionally, he produced a number of study courses on DVD's. These would include studies on 1 Corinthians, Galatians, the Beatitudes, The Ten Commandments, Nehemiah, and the Seven Churches of Revelation.

4b (Code ) (Expenses \$ 53,332 including grants of \$ ) (Revenue \$ 84,000 )

On October 1, 2013, and as recorded on the Form 990 filed for 2013, Christian Life Educator's Network (CLEN) was transferred to another 501(c)(3) organization. Until the ministry can be moved to South Carolina under the new leadership, CLEN will continue to operate on property owned by REC Ministries. During the year 2014, CLEN made monthly reimbursement payments to REC for use of both real (\$5,000) and personal (\$2,000) property.

As explained in Schedule O, REC owns church facilities in Meridian, MS. Even though previous purchasers have asked to be relieved of debt related to the purchase, they continued to pay \$1,000 per month for eleven months in order to continue to use the facilities.
