

Car Service Payment was made to a car service and for reimbursement directly to one listed executive for transportation to and from home and work for a portion of 2014 during which the individual was unable to drive due to a medical condition.
Non-qualifying deferred compensation	In 2014, the Credit Union entered into a supplemental executive retirement plan with the President. The plan calls for annual contributions and an annual interest rate of 5.50%. The contributions are held in a Rabbi Trust. As of December 31, 2014, the Plan is fully funded and is included in other assets and other liabilities in the amount of \$538,000. This plan supersedes the Presidents prior supplemental retirement plan. The Credit Unions expense in connection with the current and former plans for the years ended December 31, 2014 and 2013 amounted to \$216,000 and \$110,000, respectively.
