Going forward, however, the Foundation will ensure that the Town of Milton is provided on an annual basis (1) written notice describing the type and amount of support provided by the Foundation during the prior tax year, (2) a copy of the Foundation's Form 990 that was most recently filed as of the date of notification, and (3) copies of the Foundation's governing documents in effect on the date of notification, to the extent not previously provided.
Part IV, Section D, Line 2	As noted, the Foundation has been in existence since 1933 and since then has worked closely with the Town of Milton to operate a public park for the benefit of the residents of the Town. Although from time-to-time representatives of the Foundation have served in leadership roles with the Town, the Foundation relies upon its historic and continuing relationship with the Town of Milton as the basis for establishing that the Foundation is responsive to the needs of the Town. As part of this ongoing relationship, the Town provides services to the park, in coordination with representatives of the Foundation and the Trust, without charge, and the Park Director is in regular communication with various Town officials.
