


The Organization receives foundation grants that are restricted as to time or use and frequently span longer than one fiscal year. The 990 presentation requires a presentation of total revenue including restricted revenue, however, the Organization budgets to its projected annual unrestricted revenue. As a result, the 990 presentation of net surplus (deficit) for a given year includes changes in temporarily restricted revenue that do not impact the current year operating activity. Below is a presentation segregating temporarily restricted revenue from operating activity for the calendar years 2014 and 2013.
