The Bureau received and evaluated 3,728 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,308 referrals were accepted for further investigation, resulting in 929 new investigative cases. After initial investigation, 697 cases were closed without criminal prosecution due to insufficient evidence of a crime

The Bureau referred 219 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 208 individuals were initially charged with insurance fraud and other crimes during 2014, and court cases involving 210 individuals reached a final disposition.
