Such ballots shall not contain any identifying numbers or marks. All voting shall be by mail ballot. The Financial Secretary furnishes to the Election Judge not less than 20 days before the election, an alphabetical list of all members eligible to vote. All members in good standing and qualified shall be entitled to vote. The Executive Board shall decide the last day on which ballots shall be received, and the date, time and place when the ballots will be counted and this information shall be enclosed with the ballot sent to the members.
