Year Up is a national nonprofit organization that enables low-income young adults (ages 18-24) to move from poverty to professional careers in one year We seek to close the Opportunity Divide-the gap between those who have access to education, resources, and living-wage employment, and those who do not Year Up's mission is to close the Opportunity Divide by providing urban young adults with the skills, experience, and support that will empower them to reach their potential through professional careers and higher education In achieving our mission, Year Up acts as an "opportunity broker" between young adults and corporations lacking access to a well-trained workforce and a pipeline of talent for approximately 14 million vacant jobs that companies will struggle to fill between now and 2020 In 2013, during a time of historic youth unemployment and the graduation of our largest class to date, Year Up saw 86% of its alumni go on to pursue full-time employment or education within four months of graduating Those employed are earning an average starting wage of \$15.86 per hour
