A Child's Hope Foundation continued focusing it's volunteer efforts in Mexico in 2014 We increased the number of our Mexico work project trips in 2014 to seven, taking a total of 307 volunteers to three orphanages in Baja California, Mexico and one orphanage in Guaymas, Sonora, Mexico We delivered groceries, toys, clothing, educational and medical supplies Our volunteers built retaining walls, cement pads, sidewalks, beds, and remodeled orphanage dormitories Our volunteers served breakfast to children living in the old city dump in Tijuana, Mexico We also spent a significant amount of time caring for infants and playing with the other children in the orphanages to deepen our friendships with these children and their caregivers
