RHODE ISLAND BOY SCOUTS IS A BENEFICIARY OF THE INCOME FROM TWO IRREVOCABLE TRUSTS HELD IN PERPETUITY BY AN INDEPENDENT TRUSTEE. RHODE ISLAND BOY SCOUTS HAS AN IRREVOCABLE RIGHT TO RECEIVE A PORTION OF THE INCOME EARNED ON THE TRUSTS' ASSETS BUT WILL NEVER RECEIVE THE TRUSTS' CORPUS. THE BENEFICIAL INTEREST IN IRREVOCABLE PERPETUAL TRUSTS IS REPORTED IN THE STATEMENT OF FINANCIAL POSITION AT THE FAIR MARKET VALUE OF ITS' INTEREST IN THE TRUST. THE 2013 FINANCIAL STATEMENTS HAVE BEEN RESTATED TO RELECT RHODE ISLAND BOY SCOUTS' BENEFICIAL INTEREST IN THE IRREVOCABLE PERPETUAL TRUSTS.
