

The 2014 Financials were formally reviewed and approved at the January 2015 meeting.

The Treasurer has prepared the Form 990 using the financial included in the approved report. This Form 990 has been sent to the Board of FNLL as a material matter record. Any comments from the Board has been incorporated into the final submission of the filed Form 990.

Part VI: Line 19:

As noted above, Financial Statements are prepared and presented monthly at the league meetings open to all (volunteer) members.

Other documents are available upon request. The league website at fnll.org, contains various documents as well.

Line b:

FNLL does have volunteer members. This makes up our general member population which consists of parents for our 700 + players.

Many of these members also serve as coaches and support other league duties. The general membership is invited to the monthly league meetings.

Line 7a:

FNLL holds annual elections for its Board of Directors. The annual election is held at the November monthly meeting. Any member may run for a position through nomination or self-nomination. Members then vote for the Board of Directors based on the nominated candidates.

Part IX: Line 24e:

Includes Baseball Clinic Expense of \$23,167, Little League Charter fee \$5,945, Utilities Expense of \$3,517, Registration refunds of \$3,048, Registration Expense of \$1,006, Storage Rental of \$3,048 and the other Misc. Expenses of \$5,681

Overall expenses increased year-over-year by \$29,309 (13%). The primary increase in expenses was that FNLL added Baseball Clinics to help train our kids and added a Field & Maintenance contract for the upkeep of our fields. Even with these added expenses, FNLL was cash flow positive for the year (8,322).
