APHRC's mission is "to be a global center of excellence, consistently generating and delivering relevant scientific evidence for policy and action on population, health and education in Africa. It has 3 core programs which are research, research capacity strengthening and policy engagement & communication. The research is organized into 5 program areas of population dynamics & reproductive health, urbanization and wellbeing, health challenges and systems, education, and aging and development."

Research Capacity Strengthening (RCS)

1. The program supported 17 new doctoral students drawn from several universities in Africa in addition to giving 3 re-entry grants to graduated students under the African Doctoral Dissertation Research Fellowships (ADDRF). This brought the total number supported by the program to 172 students since its commencement in 2008. 93 have successfully completed their studies and most of the graduates have been retained in their institutions in Africa.

2 The Consortium for Advanced Research Training in Africa (CARTA), an initiative involving 9 African universities, 4 African research institutes & selected northern partners has had 115 doctoral students undergo training, 27 joining in 2014. The program, was able to:

- continue with a model collaborative doctoral training program with strong supervision and mentoring components.
- strengthen infrastructure, skills & faculty commitment to lead & manage research initiatives within the institutions
- contribute to the improvement of environments at African universities with the aim of facilitating and motivating researchers to stay and contribute to scholarly work within the region. Eight have successfully completed their studies and most of the graduates retained in their institutions in Africa

The Health Challenges and Systems (HCS) Research Program - This program is at the forefront of regional research to understand & health challenges that affect most people in sub-Saharan Africa. Major activities and achievement for 2014 include:

- 1. Launched Non-Communicable Diseases Knowledge Sharing Portal and continued to host the portal. The web-based portal provides a one-stop information hub on Non-Communicable Diseases for public health practitioners, researchers, health care providers, policymakers and the general public, in Kenya.**
- 2. Completed the upgrade of facilities and provision of medical equipment to health centers in Korogocho & Viwandani slums of Nairobi to enable them offer the best quality health services that is appropriate for their levels. In addition two incinerators have been constructed in Makadara and Kasarani areas of Nairobi to serve the two sub-counties. Two ambulances were provided, one each to serve the two communities of Korogocho and Viwandani in Nairobi.**
- 3. Facilitated the training of 180 community health workers in maternal, newborn & child health technical modules under the community health strategy, facilitated capacity building of Community Health Extension Workers in the two sub-Counties, facilitated training of health managers, in the two sub-counties of Makadara and Kasarani.**

Population Dynamics Program

- 1. Assessed the potential social harms & abuses of using oral HIV self-testing in Kenya with the objective of informing the development of pilot programs using HIV oral self tests to be implemented and evaluated using rapid impact evaluations.**
 - 2. Conducted "Meeting the Unmet Need for Family Planning & Improving Access to Safe Abortion Services (STEP UP)" project which seeks to improve access to family planning & safe abortions in Kenya, Ghana, Senegal, Bangladesh & India. The project is on-going.**
 - 3. Continued with evaluation of a set of interventions on improving the delivery and uptake of family planning in Western Kenya with the aim of reversing the stall of fertility decline in this particular region.**
- Impact: A noticeable expansion of community health workers' activities and a strong involvement of the Ministry of Public Health and Sanitation at the national, provincial and district levels. Study got the government to invest into family planning in two counties.**
- 4. Conducted the abortion costing project that sought to generate and disseminate scientific evidence on the cost of unsafe abortion as well as the constraint that providers face in offering quality abortion-related care to women in Kenya. The study is expected to give insights on how to improve reproductive health by providing evidence on the cost of treating induced unsafe abortion in Kenya.**
