Healing Program - In 2014, we combined our formerly separate Medical and Healing Homes projects into one united Healing program. Hundreds of surgeries and hospital treatments were provided for these wonderful children in 2014, through our strong partnerships with children's hospitals in China. We also held another successful cleft surgery exchange in Kaifeng, Heanan province in April. During 2014 we had 68 medically fragile children stay in our healing center, who came from 18 orphanages and 10 provinces throughout China. Our Healing Homes provide the specialized and intensive care needed for babies born with heart defects, prematurity, anal atresia, cleft lip, and more.

Education Program - In 2014, 271 students were enrolled in LWB Education programs, including our Believe in Me Schools which are built inside of orphanages to bring the gift of education to children with medical needs, tuition assistance programs, and LWB's Secondary and Higher Education Program, which helps students attend high school and college. A healthy dental project was begun in our Believe in Me Schools.

Foster Care Program - In 2014, LWB opened new programs in Lanzhou, Gansu and in Yichun, Jiangzi, while ending programs in LuAn, Anhui and Luozhi, Guizhou due to decreasing orphanage population in those areas. LWB had foster programs in 19 Chinese cities in 2014, serving 318 children. Eighty children in our program were adopted domestically and internationally.
