- 2 People Against Impaired Drivers donated half of two automated external defibrillator (AED) to local public school: one each to Idaho Falls High School and Rocky Mountain Middle School. Pat Tucker Starr (Director) provided funds for the other half of the cost.
- 3 AEDs can be used to treat sudden cardiac arrest, which is a common cause of death of young athletes
