 ENERGY SECURITY PROGRAM IN 2014, PSSSI AND ITS PARTNER ORGANIZATION, THE ENERGY FACULTY AT MASARYK UNIVERSITY, HAVE BEEN RESEARCHING AND CLOSELY MONITORING THE RAPIDLY CHANGING ENERGY SECURITY ENVIRONMENT IN CENTRAL AND EASTERN EUROPE, PARTICULARLY SINCE THE DEEPENING OF THE UKRAINE CRISIS IN MARCH 2014 RUSSIA HAS CONTINUED TO MOVE AGGRESSIVELY TO CONSOLIDATE ITS COMMANDING ENERGY POSITIONS IN A NUMBER OF COUNTRIES IN THE REGION (AS WELL AS THE BALTIC STATES), ESPECIALLY IN THE NUCLEAR ENERGY SECTOR MOSCOW HAS ALSO, IN EFFECT, "WEAPONIZED" ITS MAJOR ENERGY-RELATED STATE-OWNED ENTERPRISES, NOTABLY ROSATOM AND GAZPROM MOST OF THE REGIONAL EU AND/OR NATO MEMBER STATES HAVE RECOGNIZED THEIR PERILOUS LEVEL OF ENERGY DEPENDENCY ON RUSSIA AND ARE TAKING STEPS TO MITIGATE THE GROWING RISKS ASSOCIATED WITH SUCH DEPENDENCY IN THIS CONNECTION, THE EU'S THIRD ENERGY PACKAGE HAS BEEN A HIGHLY USEFUL TOOL IN PROVIDING CENTRAL AND EASTERN EUROPEAN CAPITALS WITH POLITICAL COVER AND DIVERSIFICATION REQUIREMENTS TO SEEK TO EXTRICATE THEMSELVES FROM THE POLITICAL AND STRATEGIC LEVERAGE BEING EXERCISED BY THE KREMLIN THROUGH ITS STATE-OWNED ENERGY ENTERPRISES THAT SAID, SOME COUNTRIES SUCH AS HUNGARY AND BULGARIA HAVE SHOWN THEMSELVES AMENABLE TO ACTUALLY BOLSTERING THEIR DEPENDENCY ON RUSSIAN ENERGY SUPPLY RELATIONSHIPS, DESPITE THE ANNEXATION OF CRIMEA AND CONTINUED MOSCOW-SPONSORED TURMOIL AND CONFLICT IN EASTERN UKRAINE TO ENRICH PSSSI'S UNDERSTANDING OF THIS REGIONAL ENERGY SECURITY DYNAMIC, IT CONVENED TWO ROUNDTABLE SESSIONS IN PRAGUE, EACH INVOLVING SOME THIRTY ENERGY EXPERTS FROM NEARLY A DOZEN COUNTRIES THE FIRST WAS HELD IN EARLY FEBRUARY 2014 AT THE SAVOY HOTEL IN PRAGUE AND THE SECOND WAS CONVENED IN LATE NOVEMBER 2014 AT THE SAME LOCATION THESE WERE PARTICULARLY ILLUMINATING SESSIONS, WHICH INCLUDED PRESENTATIONS BY JAMES HENDERSON, OF THE OXFORD INSTITUTE FOR ENERGY STUDIES, THE DIRECTOR OF CZECH FOREIGN INTELLIGENCE , AND THE PRESIDENT AND CEO OF ITOCHU EUROPE NINE FOREIGN EMBASSIES WERE REPRESENTED AT THE FIRST ROUNDTABLE AND SIX IN THE SECOND SESSION IN PRAGUE THE REPORT ITSELF HAS ALREADY EXCEEDED 100 PAGES AND IS NOT YET COMPLETE MASARYK UNIVERSITY (MUNI) AS WELL AS PSSSI HAVE CONDUCTED NUMEROUS INTERVIEWS IN REGIONAL CAPITALS AND HAVE SELECTED SEVERAL CASE STUDIES FOR ILLUSTRATIVE PURPOSES WHEN THE STUDY IS COMPLETED IT WILL BE PRESENTED AND REVIEWED AT A LARGE CONFERENCE SCHEDULED FOR JUNE 21-22, 2015 IN PRAGUE, IN THE MEETING HALL OF THE CZECH SENATE (WHICH HAS LARGELY DONATED ITS FACILITY) WE EXPECT ABOUT 100 OR MORE PARTICIPANTS, INCLUDING MEDIA REPRESENTATIVES THE CONFERENCE WILL BE "ON THE RECORD" TO MAXIMIZE COVERAGE
