TECHNOSERVE DEVELOPS BUSINESS SOLUTIONS TO POVERTY BY LINKING PEOPLE TO INFORMATION, CAPITAL AND MARKETS. IT HELPS GROW STRONG MARKETS THAT CREATE INCOME, JOBS AND WEALTH FOR POOR PEOPLE IN THE DEVELOPING WORLD. TECHNOSERVE'S PROGRAMS ADDRESS MARKET INEFFICIENCIES IN THREE PRIMARY WAYS. THEY DEVELOP CAPACITY BY HELPING INDIVIDUALS AND COMMUNITIES ACQUIRE SKILLS, SHARE KNOWLEDGE AND APPLY TECHNOLOGIES NEEDED TO BUILD SUCCESSFUL FARMS AND BUSINESSES, THEY STRENGTHEN MARKET CONNECTIONS BY COORDINATING AMONG INDUSTRY PLAYERS AND CONNECTING EMERGING BUSINESSES AND FARMS TO CAPITAL, NETWORKS AND SUPPLIERS, AND THEY IMPROVE THE BUSINESS ENVIRONMENT BY ADDRESSING THE POLICIES, INFORMATION AND INCENTIVES THAT HELP MARKETS FUNCTION BETTER AND ENCOURAGE SELF-SUSTAINING ECONOMIC ACTIVITY. IN 2014, TECHNOSERVE ASSISTED 325,152 FARMERS TO INCREASE THEIR REVENUES BY MORE THAN \$37.8 MILLION, SUPPORTED 2,986 BUSINESSES TO GENERATE INCREMENTAL REVENUES OF MORE THAN \$16.5 MILLION, AND SUPPORTED GROWTH THAT LED TO THE CREATION OF 5,610 JOBS PAYING MORE THAN \$6.9 MILLION IN WAGES. OVERALL, THESE INCOME SOURCES BENEFITED 1.7 MILLION PEOPLE IN 29 COUNTRIES THROUGHOUT AFRICA, LATIN AMERICA AND ASIA. RECOGNIZING THAT ACCESS TO FINANCE IS A SIGNIFICANT BARRIER FOR SMALLHOLDERS AND ENTREPRENEURS IN THE DEVELOPING WORLD, TECHNOSERVE HELPED MOBILIZE NEARLY \$23.9 MILLION IN FINANCING TO FARMERS AND BUSINESSES IN 2014. TECHNOSERVE ALSO CONTINUED FOCUSING ON ITS COMMITMENT TO ENGAGE AND BENEFIT WOMEN ACROSS ALL OF ITS PROGRAMS, WITH WOMEN ACCOUNTING FOR 32 PERCENT OF ALL BENEFICIARIES IN 2014. IN EAST AFRICA, TECHNOSERVE EXPANDED ITS EFFORTS TO ADDRESS YOUTH UNEMPLOYMENT BY LAUNCHING THE SECOND PHASE OF THE SUCCESSFUL STRENGTHENING RURAL YOUTH DEVELOPMENT THROUGH ENTERPRISE PROGRAM (STRYDE), MORE THAN 10,400 YOUNG MEN AND WOMEN PARTICIPATED IN STRYDE TRAINING IN 2014, BUILDING THE SKILLS THEY NEED TO START SMALL BUSINESSES, SECURE FORMAL JOBS OR EXPLORE OPPORTUNITIES IN AGRICULTURE. IN WEST AND SOUTHERN AFRICA, TECHNOSERVE EXPANDED ITS ENTERPRISE DEVELOPMENT WORK INTO TWO NEW LOCATIONS - BENIN AND BOTSWANA - TO SUPPORT THOUSANDS OF ENTREPRENEURS IN GROWING THEIR BUSINESSES AND CREATING SUSTAINABLE JOBS IN THEIR COMMUNITIES. IN LATIN AMERICA, TECHNOSERVE WORKED WITH PERUVIAN FARMERS AND BUSINESSES TO DEVELOP THE COFFEE AND COCOA VALUE CHAINS AS SUSTAINABLE, LEGAL AND PROSPEROUS ALTERNATIVES TO COCO PRODUCTION, GENERATING MORE THAN \$3.7 MILLIONS IN INCREMENTAL REVENUE. AND IN ASIA, TECHNOSERVE HELPED FARMERS IN THE RATNAGIRI REGION OF INDIA INCREASE THEIR INCOMES BY IMPROVING THE PRODUCTIVITY AND QUALITY OF THEIR CASHEW NUT AND FRUIT CROPS.
