Nursing Facility Initiative to Reduce Avoidable Hospitalizations (CMS NF) This project is supported by a federal cooperative agreement with CMS with the goal of reducing avoidable hospitalizations for long-stay nursing facility residents. The Foundation is partnering with other New York organizations and serving as one of seven organizations across the country to achieve this goal, in collaboration with 29 New York nursing facilities. The CMS NF program represents approximately 79% and 83% of total grant and contributions revenue in 2014 and 2013, respectively, and approximately 60% and 65% of total grants receivable as of December 31, 2014 and 2013, respectively.

The Foundation is partnering with other New York organizations and serving as one of 26 contractors across the country to achieve these goals, in collaboration with New York hospitals.
