AS A NATIONAL COMMUNITY DEVELOPMENT FINANCIAL INSTITUTION (CDFI), NFF PROVIDES FINANCING AND ACCESS TO ADDITIONAL CAPITAL TO MISSION-DRIVEN ORGANIZATIONS THAT SERVE LOW-INCOME PEOPLE AND COMMUNITIES IN 2014, NFF CLOSED 13 NEW LOANS TOTALING \$19.1 MILLION AND CONTINUED TO FINANCE \$53.3 MILLION IN LOANS TO EDUCATIONAL INSTITUTIONS, HEALTH CENTERS, HUMAN SERVICES NONPROFITS, AND OTHER ORGANIZATIONS THAT CREATE TRANSFORMATIONAL IMPACT.
